Chief Data Officer will play a key role in the Office of Data in collecting, curating, and preserving data related to all activities of IISc as well as analyzing the data to provide strategic inputs to the IISc enterprise.

## **Duties & responsibilities:**

- Coordinate with various offices, centers, units, departments, and SAP ERP of IISc to collect multiple datasets pertaining to HR, Academics, Projects, Finance, Funding, Ranking, IoE, and Institutional Research DataManagement
- Evaluate the datasets for consistency and completeness&Conduct Data Audit
- Perform data management and benchmarking activity as per the needs of the IISc leadership
- Perform data analysisusing statistical tools, Perform publication data analysis for rankings
- Develop a classification system for efficient organization and retrieval of data
- Be responsible for data licensing and long-term preservation of data
- Coordinate timely data submission for ranking agencies such as NIRF, THE, and QS
- Coordinate and support Office of Data and IISc Rankings and Performance Committee
